The Petitioners have filed this petition seeking to modify the conditional amount imposed in the order dated 02.07.2021 made in Crl.O.P.No.11414 of 2021.

2.The learned counsel appearing for the petitioners submitted that the petitioners are very poor and that they are not in a position to deposit the conditional amount and prayed this Court to modify the amount.

3.Heard the submissions made by the learned Government Advocate.



4. Considering the submission made by the learned counsel appearing for the petitioners, the amount imposed on the petitioners in the order dated 02.07.2021 made in Crl.O.P.No.11414 of 2021 is reduced from Rs.25,000/- to Rs.15,000/-. The conditional amount is accordingly modified.
