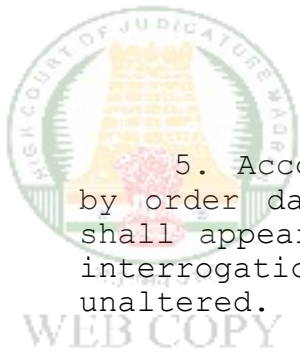

Vide Order dated 16.12.2020 this Court had modified the condition in CRL MP No. 7637 of 2020 in CRL OP No. 15803 of 2020 on certain conditions.

2. This petition has been filed by the petitioner seeking further relaxation of the conditions.

3. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

4. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.



5. Accordingly, the condition insofar as appearance as imposed by order dated 16.12.2020 alone stands modified and the petitioner shall appear before the respondent police as and when required for interrogation on receipt of summons. All other conditions remain unaltered.
