2. Considering the averments made in the petition, this petition is allowed on condition that the appellant pays a sum of



Rs.2,000/- [Rupees Two Thousand Only] to the Dean, Rajiv Gandhi Government General Hospital, Chennai within a period of two weeks from the date of receipt of a copy of this order, failing which, petition to condone the delay, would stand dismissed, without further reference to this Court.

4. On payment of costs within the stipulated period and production of receipt, Registry is directed to number the Writ appeal, if it is otherwise in order and post the same for admission.

5. C.M.P.No.12149 of 2021 is ordered, accordingly.
