Vide Order dated 15.12.2020 in Crl.MP.No.7235 of 2020 in Crl.OP.No.11952 of 2020, this Court directed the petitioners to report before the respondent police on the first day of every month until further orders. Again, this petition has been filed by the petitioners seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 15.12.2020 alone stands modified and the petitioner shall appear before the respondent police as and when required for interrogation on receipt of summons. All other conditions remain unaltered.
