Though this writ petition has been filed seeking for issuance of a Writ of Mandamus forbearing the respondents from disturbing the petitioner's peaceful possession and enjoyment of the land at S.No.57/A2A1 measuring to an extent of 480 square feet at Shanthi Nagar, Ring Road, Hosur, Krishnagiri, it was found that the petitioner is an encroacher.
