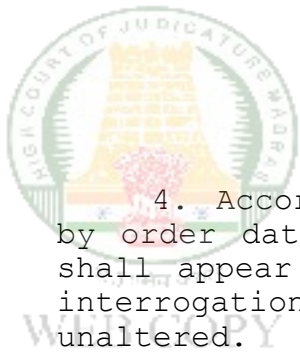

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioners have been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 02.07.2021 alone stands modified and the petitioners shall appear before the respondent police as and when required for interrogation on receipt of summons. All other conditions remain unaltered.
