2.Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.



3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 16.09.2020 alone stands modified and the petitioner shall appear before the respondent police on every Monday at 10.30.a.m. till the filing of charge sheet. All other conditions remain unaltered.
