The petitioner challenges the impugned order of detention in Cr.M.P.No.20/D.O./2021/E1, dated 19.07.2021, detaining her husband as "DRUG OFFENDER" under Section 3(1) of Tamil Nadu Act 14 of 1982.

2. The learned Additional Public Prosecutor submitted that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.4406, Home, Prohibition and Excise (XII) Department, dated 27.09.2021 and he has also produced a copy of the Government Order.

Recording the same, this Habeas Corpus Petition stands closed.
