4. Accordingly, the condition insofar as appearance as imposed by order dated 09.06.2021 alone stands modified and the petitioner shall appear before the respondent Police, on every Monday and Friday at 10.30 a.m. till the investigation is completed and charge sheet is



filed and thereafter, shall appear before the concerned trial Court on each and every date of hearing. All other conditions remain unaltered.
