Accordingly, the condition insofar as appearance as imposed by order dated 06.07.2021 alone stands modified that till filing of the charge sheet, the petitioners are directed to appear before the respondent police on every Monday at 10.30 a.m, and thereafter, the petitioners are directed to appear before the concerned court on each and every hearing dates at 10.30 a.m, until further orders. All other conditions remain unaltered.
