Vide Order dated 17.12.2020, this Court had already modified the condition imposed on the petitioner in Crl.M.P.No.7972 of 2020 in Crl.O.P.No.11317 of 2020 dated 17.12.2020. Again, this petition has been filed by the petitioner seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.



3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 17.12.2020 alone stands modified and the petitioner shall appear before the respondent police as and when required for interrogation on receipt of summons. All other conditions remain unaltered.
