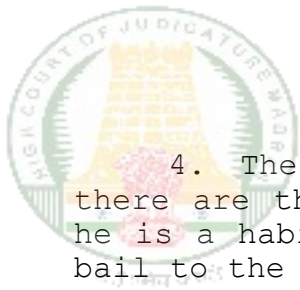
PETITION FOR BAIL 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who was arrested on 01.03.2021 and remanded to judicial custody for the offences under Sections 302, 148, 120(b) & 506(ii) of IPC, in S.C.No.46 of 2019 on the file of the I Additional District Judge, Salem District, in Crime No.219 of 2018 on the file of the respondent police, seeks bail.

2.The case of the prosecution is that when the case is pending at trial stage, the petitioner did not appear before the trial Court for hearings, the trial Court had issued NBW against the petitioner dated 18.01.2021. Further, the petitioner was arrested on 01.03.2021 and remanded to judicial custody.

3. The learned counsel for the petitioner submits that the petitioner is now ready to appear before the trial Court and to abide by any stringent conditions imposed by this Court. Hence he prays for grant of bail to the petitioner.



4. The learned Government Advocate (Crl.Side) submitted that there are three previous cases pending as against the petitioner and he is a habitual offender. Hence, he vehemently opposed for grant of bail to the petitioner.

5. Considering the facts and circumstances of the case and also the fact that there are three previous cases pending as against the petitioner and he is a habitual offender, this Court is not inclined to grant bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
