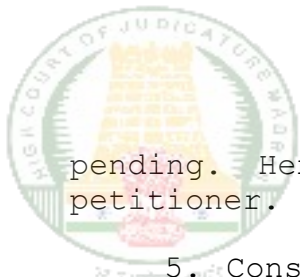
ORDER : The Court Made the following order :-

The petitioner, who was arrested on 25.07.2021 and remanded to judicial custody for the alleged offences punishable under Sections 24 (1) of Cigarette and Other Tobacco Products Act, 2003 and 328 of IPC, in Crime No.614 of 2021, on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner along with other accused persons were found in illegal possession of banned tobacco products worth about of Rs.10,000/- Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he is no way connected with the alleged offences and he has been falsely implicated in this case. He further submits that the petitioner has been in jail from 25.07.2021. Hence he prays for grant of bail to the petitioner.

4. The learned Government Advocate (Crl.Side) submitted that there is one previous case pending as against the petitioner for the offence under Section 302 of IPC and the investigation is still



pending. Hence, he vehemently opposed for grant of bail to the petitioner.

5. Considering the facts and circumstances of the case and also the fact that there is one previous case pending as against the petitioner and considering the gravity of offence, this Court is not inclined to grant bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
