Vide order dated 23.06.2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the conditions.

2. Learned Addl. Public Prosecutor appearing for the respondent, on instruction, submits that the petitioners have been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 23.06.2021 alone stands modified and insofar as the 1st petitioner is concerned, he shall appear before the respondent Police, on every Monday at 10.30 a.m. and in respect of the 2nd petitioner is concerned, she shall appear before the respondent Police as and when required, till the investigation is completed and charge sheet is filed and thereafter, the petitioners shall appear before the concerned trial Court on each and every date of hearing. All other conditions remain unaltered.
