PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who was arrested on 14.07.2021 and remanded to judicial custody for the alleged offences punishable under Section 399 of IPC, in Crime No.94 of 2020, on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner along with other accused persons appear to have planned to commit dacoity. Hence, the complaint.

3.The learned counsel appearing for the petitioner would submit that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case. Therefore, he prays for grant of bail to the petitioner.

4.The learned Government Advocate (Crl.Side) would submit that there are six previous cases pending as against the petitioner and he is a history sheeter. Hence, he vehemently opposed for grant of bail to the petitioner.

5.Considering the fact that there are six previous cases pending as against the petitioner, which shows that he is a history sheeter, this Court is not inclined to grant bail to the petitioner.



6. Accordingly, this Criminal Original Petition is dismissed.
