2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 23.06.2021 alone stands modified and the petitioner shall appear before the respondent police every Monday at 10.30 am till the filing of charge sheet. Thereafter, the petitioner shall appear before the trial court on each and every hearing date until further orders. All other conditions remain unaltered.
