3.In view of the above development, nothing survives in this petition and accordingly the same is closed. Consequently, connected miscellaneous petition is closed.

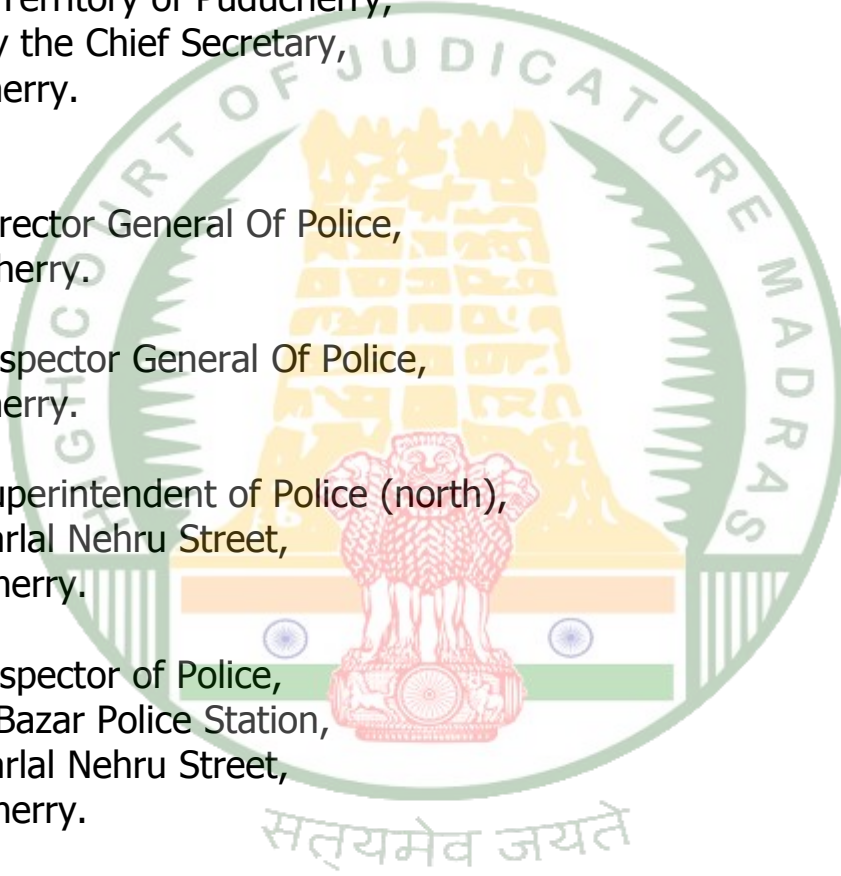

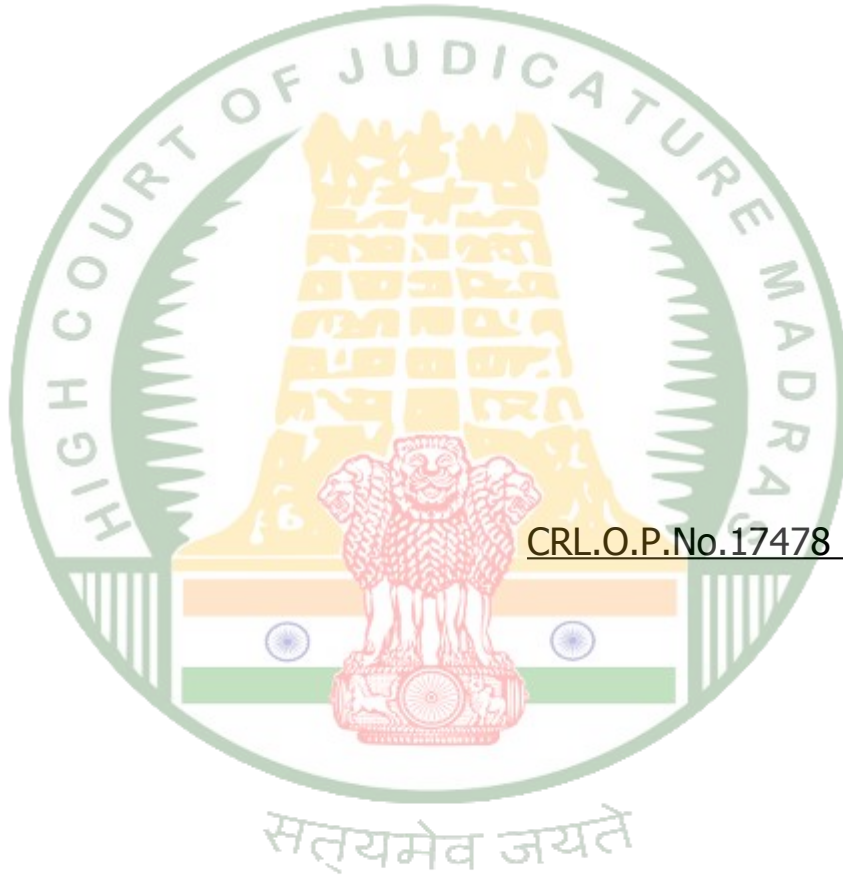
