The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has not been approved by the Government by its order in G.O.Rt.No.3617, Home, Prohibition and Excise (XV) Department, dated 11.08.2021 and he has also produced a copy of the Government Order.
