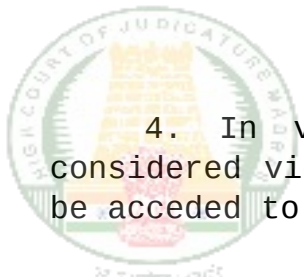

All other conditions remain unaltered.
