This public interest litigation has been filed for an action pursuant to the representation made by the petitioner for completion of the acquisition and construction of the road. This Court, while hearing the connected petitions, gave liberty to the petitioners therein to maintain a civil suit for declaration of title and injunction and thus, dismissed the writ petitions and therefore stay order has come to an end.

2. In view of the above, the Government would now proceed further to complete the acquisition process and construction of the road, unless an injunction is granted by the court.

3. With the above directions, this public interest litigation is disposed of. There will be no order as to costs.
