This Court has already directed the first and second respondent to conduct and complete the enquiry within the period of two months and pass the final award for the land which was acquired on 04.06.2012. Even then, the respondents did not take any steps to pass the award. Therefore, the petitioner submitted a representation before the third respondent on 23.03.2021.

4. Considering the above, the third respondent is directed to comply the order passed by this Court dated 01.04.2019 within a period of eight weeks from the date of receipt of a copy of this order.

5. With the above direction, this writ petition is disposed of. No order as to costs.
