4. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners A1/A2 could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 13.07.2021 alone stands modified that till filing of the charge sheet, the petitioners A1/A2 are directed to appear before the respondent police on every Monday at 10.30 a.m, and thereafter, the petitioners A1/A2 are directed to appear before the concerned court on each and every hearing dates at 10.30 a.m.. All other conditions shall remain unaltered.
