The said appeal had been filed seeking cancellation of patta issued by the 2nd respondent/Tahsildar, * **Hosur**, Krishnagiri District. The respondents 3 and 4 are having the benefit of the patta as on date.

3. It is informed that notice had also not been issued in the appeal.

4. Therefore, a specific strict time line cannot be given for disposal of the appeal. But, however, after following due process and after giving notice to all the sides and hearing the parties, the 1st respondent may endeavour to dispose of the appeal on or before 30.11.2021.

5. The writ petition stands disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
