PRAYER:-

This Writ Petition is filed under Article 226 of the Constitution of India, praying for issuance of Writ of Certiorarified Mandamus, calling for the records in the order passed by the 2nd Respondent in Se.Mu. Order R.V.3/5165/2011 dated 28.11.2012 and quash the same as arbitrary illegal unjustifiable and against the principles of natural justice and further direct the 2nd and 3rd Respondents to refund the sum of Rs.1,40,000/- (Rupees One Lakh Forty Thousand Only) to the petitioner within a specific time frame.
