W.P. No. 14987 of 2020: Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Mandamus, directing the first respondent to consider the representation dated 13.08.2020 seeking the upgradation of the existing Nursery and Primary Un-aided schools to middle schools and also to admit the children admitted under 25% of the RTE Quota in Nursery and Primary Schools to join in the neighborhood Matriculation schools which are located within 3 kms radius of the residence of the children so as to ensure their right to free and compulsory education upto the age of 14 as provided under Right of Children to Free and Compulsory Education Act 2009 from the academic year 2020 onwards.

W.P. No. 14987 of 2020: Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Mandamus, directing the respondents to consider the representation of the petitioner dated 17.08.2020 and to pass an order permitting the member schools, who have been granted sanction for conducting primary school, to enroll students from standards 6 to 8 during the academic year 2020-21, 2021-2022 and 2022-2023 respectively in order to enable the children belonging to disadvantaged group and weaker section to continue to studies in the same school admitted under the Right of Children to Free and Compulsory Education Act 2009.
