3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 30.07.2021 alone stands modified and the petitioners shall appear before the respondent police every Monday at 10:30 am till the filling of charge sheet. Thereafter, the petitioners shall appear before the trial court on each and every hearing until further orders. All other conditions remain unaltered.
