Vide order dated 22.07.2020, this Court had enlarged the petitioners on bail on certain conditions. This petition has been filed by the petitioners seeking further relaxation of the conditions imposed on the Crl.M.P.No.8212 of 2020 by order dated 18.12.2020.

2. Learned Government Advocate (Crl.Side) appearing for the respondents, on instruction, submits that the petitioners have been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 18.12.2020 alone stands modified and the petitioners shall appear before the respondent police fortnightly i.e., on 1st day and 15th day of every Month at 10.30 am till the filing of charge sheet. Thereafter, the petitioners shall appear before the trial court on each and every hearing until further orders. All other conditions remain unaltered.
