The petitioner challenges the impugned order of detention in D.O.No.37/2021, dated 04.08.2021, detaining her husband as "BLACK MARKETEE" under Section 3(1) r.w. 3(2) (a) of the Prevention of Black Marketing and Maintenance of Supplies of Essential Commodities Act, 1980 (Central Act 7 of 1980).

2. The learned Additional Public Prosecutor submitted that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.208, Co-operation, Food and Consumer Protection (E1) Department, dated 30.09.2021 and he has also produced a copy of the Government Order.

Recording the same, this Habeas Corpus Petition stands closed.
