The petitioner is wife of the detenu viz., Rajasekar s/o.Baskaran, aged 40 years. The detenu has been detained by the second respondent by his order in C.M.P.No.50/Goonda/Salem City/2021 dated 26.07.2021, holding him to be a "Goonda", as contemplated under Section 2 (f) of the Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

Learned Additional Public Prosecutor would submit that the detention order passed against the detenu in C.M.P.No.50/Goonda/Salem City/2021 dated 26.07.2021, on the file of the second respondent is revoked vide G.O.Rt.No.5017, Home, Prohibition and Excise (XIV) Department, dated 28.10.2021 and produced a copy of the said order.

In view of the above, this petition is closed as it has become infructuous.
