PRAYER: Appeal against the Decree of the IV Additional District and Sessions Court, Coimbatore in O.S.No.585 of 2008 dated 12.12.2012.

Decree: This Appeal coming on for hearing on this day and upon perusing the judgment and decree of the Trial Court, and the material papers in the suit and upon hearing the arguments of Mr.N.Manokaran, Advocate for the Appellants and of Dr.C.Ravichandran, Advocate for First Respondent and the parties herein having entered into Court a Joint Memo of Compromise requesting the Court to pass a decree in the Appeal terms thereof and the Memo of Compromise duly signed by the parties (Left Thumb impression and N.Ramamurthy(1st Respondent/Plaintiff) made in LTI and by their respective Counsel that the memo of compromise wehrein annexed herein and this Court while observing that the 1st Respondent herein/Plainfiff have already been deposited the balance sale consideration as per decree of the Trial Court and this Court the memorandum of compromise memo is taken on file and recorded disposing of appeal terms of Joint Memorandum of Compromise, doth order and decree as follows:

i) that the Appellants herein/Defendants be and hereby are agreed to pay a Sum of Rs.40,00,000/- (Rs.Fourty Lakhs Only) to



the 1st Defendant herein/plaintiff by way of Rs.15,00,000/- deposited in the bank account of N.Ramamurthy through TRGS in UTR No.HDFCR52020101452140014 and balance amount of Rs.Twenty Five lakhs paid in cash.

ii)that the details of payment of Rs.40,00,000/-(Rs.Fourty Lakhs Only) duly accepted by the 1st Respondent /Plaintiff.

iii)that the plaintiff agrees to waive of his right accrued under the judgment and decree in O.S.No.585 of 2008 1st Respondent/Plaintiff shall also agreed to withdraw E.P.No.18/2014.

iv)that the 1st Respondent/Plaintiff be and hereby is permitted to withdraw the amount of sale consideration deposited by him to the credit of OS.NO.585 of 2008 on the file of the IV Additional District and Sessions Judge, Coimbatore.

v)that there be no order as to costs in this Appeal Suit.
