O R D E R

The petitioner who was arrested and remanded to judicial custody on 27.07.2021 for the offence under Section 420 of I.P.C. r/w. 15(3) of Indian Medical Council Act and Section 8 of the Tamilnadu Private Clinical Establishment Regulation Act in Crime No.593 of 2021 on the file of the respondent police, seeks bail.

2.It is the case of the prosecution that the petitioner is alleged to have treated the patients in the absence of Doctor in the Hospital, however, she is not a qualified person.

3.The learned counsel appearing for the petitioner would submit that the petitioner has not committed any offence as alleged by the prosecution. The learned counsel, on instructions, further submitted that the petitioner is ready to deposit a sum of Rs.25,000/- to the Medical Officer/Dean, Government Hospital and Medical College, Tiruvannamalai, to enable the Medical Officer/Dean to use the aforesaid amount for the purpose of treating the Covid-19 patients.



(g) if the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
