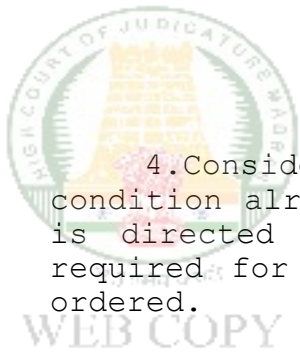

The Petitioner has filed this petition seeking to relax the conditions imposed by this Court in Crl.O.P.No.11578 of 2021 for the offences punishable under Section 6 r/w 5(1) of POCSO Act 2012, section 9 and 10 of Prohibition of Child Marriage Act, in Crime No.7 of 2021, while granting anticipatory bail.

2.Heard the learned Counsel appearing for the petitioner.

3.The learned Government Advocate (Crl side) submitted that the petitioner is complying with the condition regularly.



4. Considering the facts and circumstances of the case, the condition already imposed by this Court is relaxed and the petitioner is directed to appear before the respondent police, as and when required for interrogation on receipt of summons. This petition is ordered.
