Writ Petitions under Article 226 of the Constitution of India praying that in the circumstances stated therein and in the respective affidavits filed therewith the High Court will be pleased to issue a Writ of Mandamus or any other appropriate writ or direction in the nature of writ or order by directing the respondent to order inquiry, inspection and investigation into the affairs of the S.615 Gundalapatti Primary Agricultural Co-operative Credit Society and take appropriate action to safeguard and recover the misappropriated funds of the society by providing adequate protection to the inquiry officer appointed for that purpose.(WP.No.19510/2021)
