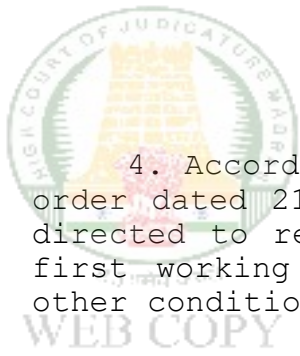

Vide Order dated 21.08.2018 in Crl.MP.No.10871 of 2018 in Crl.OP.No.16427 of 2018 modified the conditions imposed by the petitioners. This petition has been filed by the petitioners seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioners have been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners could be acceded to.

All other conditions remain unaltered.
