This application has been filed to implead the proposed respondents 4 to 6 who are the legal heirs of the deceased 2nd respondent in the O.P.

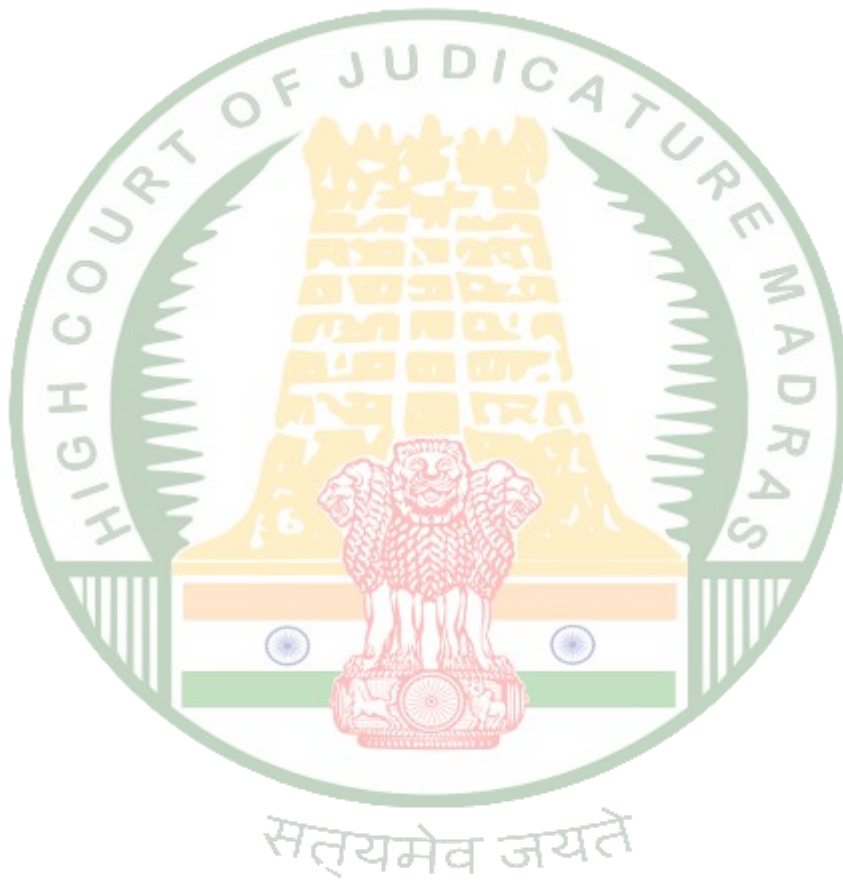
2. Originally, the O.P. is filed for Succession Certificate. Counsel appearing for the respondents 1 to 3 has no objection for allowing the application.

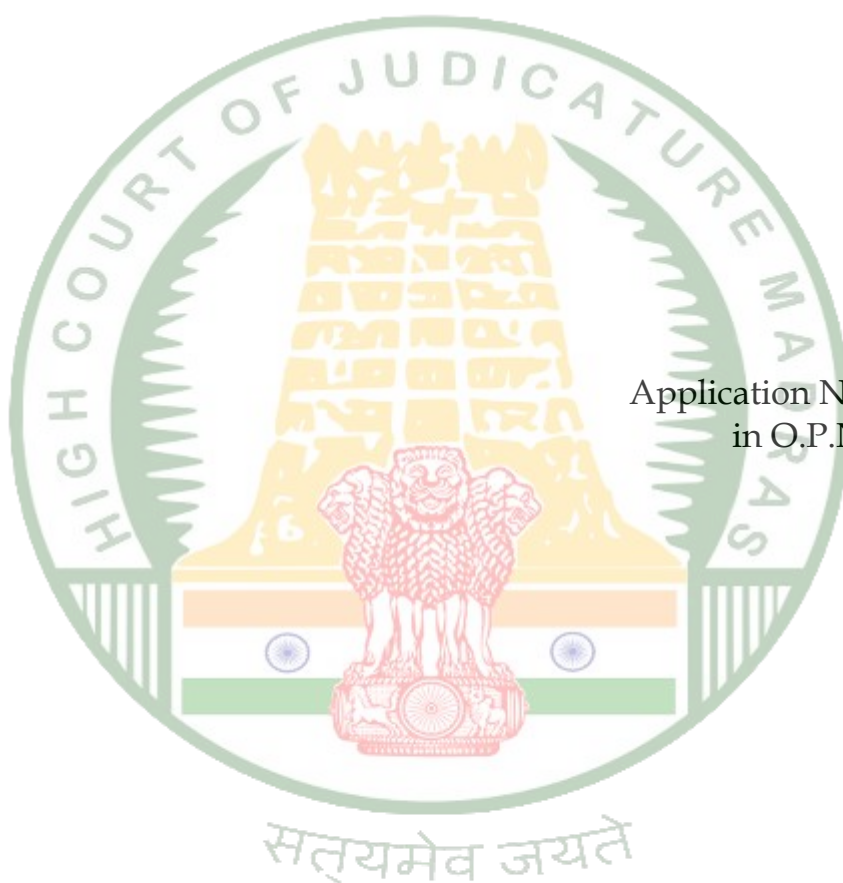
