PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest for the alleged offence under Sections 379, 430 IPC r/w 21(5) Mines and Minerals Act r/w 3 of TNPPDL Act in Crime No.70 of 2021 on the file of the respondent police, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner has involved in illegal transportation of $\frac{1}{2}$ unit of river sand by using tractor with tipper lorry.

3.The learned counsel appearing for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case.

4.The learned Government Advocate (CrI.side) submitted that the petitioner has illegally transported $\frac{1}{2}$ unit of river sand by using tractor with tipper lorry. Hence, he opposed to grant anticipatory bail to the petitioner.

5.This court is of the opinion that these type of cases are impacting large Magnitude and the petitioner is misusing the discretionary of this Court and continues with the offences affecting the environment and ecology.



6. Accordingly, this criminal original petition is dismissed.
