4. The learned Government Advocate (Crl.Side) submits that the petitioner has not complying the conditions imposed by this Court.

5. Considering the facts, the petitioner has not complied with the conditions imposed by this Court in Crl.O.P.No.3252 of 2021, this Court is not inclined to relax the conditions imposed on the petitioner.



6. Accordingly, this Criminal Miscellaneous Petition is dismissed. However, this order will not stand on the way for the petitioner to comply with the conditions imposed in Crl.O.P.No.3252 of 2021.
