This writ petition is also disposed in terms of the above order dated 22.03.2021 by directing the respondent/Neyveli Corporation to dispose the petitioner's representation/appeal dated 15.12.2016 within a period of eight weeks from the date of receipt of a copy of this order. There shall be an order of Status quo to be maintained for the present. No costs. Consequently, connected miscellaneous petitions are closed.
