Accordingly, the condition insofar as appearance as imposed by order dated 09.07.2021 alone stands modified and the petitioners should appear before the respondent police on every Monday at 10.30.a.m. till the filing of charge sheet and thereafter on every hearing date. All other conditions remain unaltered.
