Accordingly, the condition insofar as appearance as imposed by order dated 06.07.2021 alone stands modified and the petitioner shall appear before the respondent police every Monday at 10.30 am till the filing of charge sheet. Thereafter, the petitioner shall appear before the trial court on each and every hearing until further orders. All other conditions remain unaltered.
