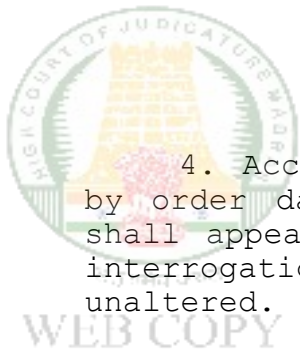

Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S. N.PALANIVEL, Advocate for the petitioner, and of MR.A.GOPINATH, Govt. Advocate (Crl. Side) on behalf of the Respondent, the court made the following order:-

Vide order dated 16.04.2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking further relaxation of the conditions imposed on Crl.M.P.No.6326 of 2021 dated 17.06.2021.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 17.06.2021 alone stands relaxed and the petitioner shall appear before the respondent police as and when required for interrogation until further orders. All other conditions remain unaltered.
