DECREE:

1. That the award passed by the Tribunal be and hereby is
enhanced to Rs.2,35,000/- (Rupees Two Lakhs Thirty Five Thousand
only) from Rs.2,25,000/- with interest at the rate of 7.5% per
annum from the date of petition till the date of deposit.

2. That the second respondent herein/Insurance Company be
and hereby is directed to deposit the enhanced award amount,
with interest and costs, less the amount already deposited, if
any, within a period of six weeks from the date of receipt of a
copy of this order.

3. That on such deposit being made, the appellant herein/ claimant be and hereby is permitted to withdraw the award amount now determined by this Court, along with interest and costs, less the amount if any, already withdrawn by making necessary applications before the Tribunal.

4. That there be no costs in this Civil Miscellaneous Appeal.
