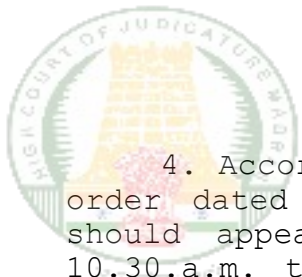

Vide Order dated 29.07.2021, this Court had enlarged the petitioners on bail on certain conditions. This petition has been filed by the petitioners seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioners have been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 29.07.2021 alone stands modified and the petitioners should appear before the respondent police on every Monday at 10.30.a.m. till the filing of charge sheet and thereafter on every hearing date till the disposal of the case. All other conditions remain unaltered.
