Today, when the matter is taken up for hearing, the learned Counsel appearing for the petitioner submitted that the Government vide G.O.MS.No. 15 Cooperation, Food and Consumer Protection Department, dated 08.02.2021 waived the entire agricultural loan obtained from the Cooperative Society, therefore nothing survives for adjudication.

3. Recording the submissions made by the learned Counsel appearing for the petitioner, the writ petition stands dismissed as infructuous. Consequently, connected Miscellaneous Petition is closed. No costs.
