2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 06.08.2021 alone stands modified that till filling of the charge sheet, the petitioner is directed to appear before the respondent police on every Monday at 10.30 a.m., till filing charge sheet. All other conditions remain unaltered.
