O R D E R

This Criminal Original Petition is filed to direct the respondent police to issue the CSR to the petitioner complaint dated 07.08.2021 and further direct them to register a case on the basis of the complaint given by the petitioner dated 17.08.2021 on the file of the second respondent police.



2.The learned Additional Public Prosecutor submitted that the respondents police have received a complaint from the petitioner and enquiry is pending.

3.In view of the submission of the learned Additional Public Prosecutor, without going into the merits and veracity of the complaint, this Court directs the respondent police to conduct preliminary enquiry and register the FIR, if cognizable offence is made out, as per the guidelines issued by the Hon'ble Supreme Court in the case of Lalitha Kumari vs. Government of Uttar Pradesh reported in AIR 2012 SC 1515. Otherwise, closure report shall be sent to the petitioner, within a period of three weeks, from the date of receipt of a copy of this order. If the petitioner feels aggrieved, they can file a protest petition.

4.With the above directions, this Criminal Original Petition is disposed of.
