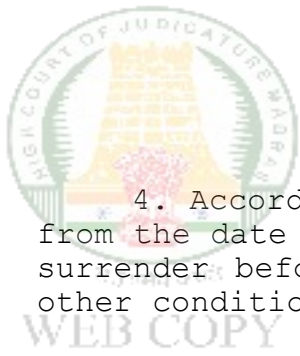

Order: This petition coming on for orders upon perusing the petition and upon hearing the arguments of M/S. KALYAN KISHEN SINGH, Advocate for the Petitioner and of MR. A.GOPINATH, Govt. Advocate (Crl. Side) on behalf of the Respondent the court made the following order:-

Vide order dated 21.01.2020 in Crl.M.P.No.605 of 2020 in Crl.O.P.No.32730 of 2019, this Court extended a period of two weeks for furnishing sureties.

2. The learned counsel for the petitioner submits that due to the lockdown for covid-19 pandemic, he was unable to arrange the sureties as ordered by the Court. This petition has been filed by the petitioner seeking further extension of time for surrender.

3. Being satisfied with the reasons shown in the affidavit filed in support of the petition, the prayer sought for by the petitioner deserves to be considered favourably.
