Vide Order dated 15.06.2021, this Court had granted anticipatory bail to the petitioner on certain conditions. This petition has been filed by the petitioner seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail. It is further submitted that investigation has been transferred to CBI.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 15.06.2021 alone stands modified and the petitioner shall appear before the CBI as and when required for interrogation till filing charge sheet and thereafter, petitioner is directed to appear before the concerned Court on each and every hearing dates at 10.30 a.m., until further orders. All other conditions remain unaltered.
