PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest for the alleged offence punishable under Sections 9 and 10 of Prohibition of Child Marriage Act, 2006 in Crime No.16 of 2021 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that a minor girl was married to the petitioner on 15.02.2021 and based on the statement of the minor girl that she was married on compulsion, based on the complaint made by the defacto complainant/Social Welfare Officer, District Child Protection Unit, Kallakurichi, the Law Enforcing Agency registered the case against the petitioner.

3.The learned counsel appearing for the petitioner submits that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case. Therefore, he prays for grant of anticipatory bail to the petitioner.

4. The learned Government Advocate (Crl.Side) submits that the statement u/s 164 Cr.P.C. has been recorded from the Victim girl.
