PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners, who apprehend arrest for the alleged offence under Section 379, 430 of IPC r/w Section 21(1) of Mines and Minerals (Development and Regulation) Act, 1957 in Crime No.278 of 2021 on the file of the respondent police, seek anticipatory bail.

2.The case of the prosecution is that the petitioners along with the other accused persons were involved in illegal transportation of 1/4 unit of river sand by using Tractor.

3.The learned counsel appearing for the petitioners submitted that the petitioners have not committed any offence as alleged by the prosecution and they have been falsely implicated in this case. Hence, he prays for grant of anticipatory bail to the petitioners.



4.The learned Government Advocate (Crl.Side) submitted that the petitioners along with other accused person have illegally transported 1/4 unit of river sand by using Tractor without valid permit and there are two previous cases of similar nature pending against the second petitioner/A2. Hence he opposed to grant anticipatory bail to the petitioners.

5.This court is of the opinion that these type of cases are impacting large Magnitude and the petitioners are misusing the discretionary of this Court and continues with the offences affecting the environment and ecology.

6.Accordingly, this criminal original petition is dismissed.
